

1. Introduction

1.1 This policy outlines the process of applications for flexible working by employees of the Wessex Learning Trust. The Trust recognises that a better work-life balance can improve employee motivation, performance and productivity, and reduce stress. Therefore, the organisation wants to support its employees achieve a better balance between work and their other priorities, such as caring responsibilities, leisure activities, further learning and other interests. The Trust is committed to agreeing any flexible working arrangements, provided that the needs and objectives of both the organisation and the employee can be met.

1.2 It is the Wessex Learning Trust's policy to encourage open discussion with employees. An employee that thinks they may benefit from flexible working is encouraged to contact their Headteacher or Line Manager to arrange an informal discussion to talk about the options. In the case of a Headteacher or member of staff employed centrally this should be the Chief Executive Officer.

2. What is Flexible Working?

2.1 Flexible working is any type of working arrangement that gives some degree of flexibility on how long, where and when an employee works.

2.2 The following flexible working options are the typical arrangements that employees will request, but the organisation recognises that there may be alternatives or a combination of options, which are suitable to both the organisation and the employee:

- **Reduced hours** – working less than a full-time schedule with corresponding adjustment to pay and benefits.
- **Term-time working** – working annual hours during school or college term times only.
- **Job sharing** – two individuals sharing the duties of a full-time position with a corresponding adjustment to pay and benefits. Job share partners must carry comparable responsibilities if the grade of each person is to be maintained.
- **Variable hours/flexitime** – selecting different start and finish times, within agreed limits, from the standard ones in a service area.
- **Compressed hours** – working a full-time week in fewer than five days. Employees working this type of arrangement must ensure their health and safety is not compromised by working long hours without adequate breaks, or by working alone in potentially dangerous situations.
- **Office-based homeworking** – where the permanent workplace is a Trust School, although the employee may work a fixed part of the week from home. No annual allowance will be made to cover costs of a home being used as an occasional workplace.

3. The Needs of the Organisation

3.1 The Wessex Learning Trust is committed to providing a range of appropriate working patterns. However, employees and management need to be realistic and to recognise that not all flexible working options will be appropriate for all roles.

3.2 Where a flexible working arrangement is proposed the academy/trust will need to take into account a number of criteria including (but not limited to) the following:

- the costs associated with the proposed arrangement
- the effect of the proposed arrangement on other staff

- the need for, and effect on, supervision
- the existing structure of the department/school
- the availability of staff resources
- details of the tasks specific to the role
- the workload of the role
- whether it is a request for a reasonable adjustment related to a disability
- health and safety issues

4. Eligibility

4.1 Any employee with at least 26 weeks of employment service has a statutory right to request flexible working.

5. Submitting a Flexible Working Request

5.1 An eligible employee is entitled to submit one flexible working request in a twelve-month period (an employee is entitled to additional requests if they relate to a statutory entitlement e.g. the Equality Act 2010 right to request reasonable adjustments).

5.2 All requests must be made to the Headteacher/Executive Headteacher/Line Manager by filling in an application form that is available from your School Office or employee internet. Any request made must include:

- the date of the application
- the changes that the employee is seeking to their terms and conditions
- the date from when the employee would like the proposed change to come into effect
- what effect the employee thinks the requested change would have on the organisation
- how, in their view, any such effect could be dealt with
- whether this is a statutory or non-statutory request
- whether a previous application for flexible working has been made
- the dates of any previous applications

5.3 If the employee is making the request in relation to the Equality Act, e.g. as a reasonable adjustment relating to a disability, this should be made clear in the application.

5.4 If an application does not contain all the required information the Headteacher/Executive Headteacher will explain to the employee what additional or amended information they need to provide and ask the employee to resubmit the request.

5.5 In most cases flexible working arrangements are agreed at the outset as permanent changes. In some cases, however, the individual may want to test an arrangement for a trial period before making a long term commitment, or a manager may suggest a trial period where the likely business impacts of a proposed working pattern are unclear.

5.6 There may be occasions where an individual only needs flexibility for a defined period, in which case a temporary fixed term arrangement may be put in place.

5.7 There are therefore three contractual options:

- Permanent change to terms and conditions of employment.
- Fixed period change in working pattern of between one and six months, after which individuals can either return to their previous hours/pattern or apply for a permanent flexible working pattern.
- Trial of a new working pattern of between one and three months, after which the working pattern will either end or continue as a permanent contractual change.

6. Meetings Regarding Flexible Working

6.1 Upon receiving a written request for flexible working the Headteacher/Executive Headteacher/Line Manager will usually seek to arrange a meeting with the employee to:

- discuss the request
- find out more about the proposed working arrangements
- how it could be of benefit to both the employee and organisation

6.2 If a meeting is arranged it will be held within 28 working days of the organisation receiving the request. This time limit may be extended with the agreement of both the employee and the Headteacher/Executive Headteacher/Line Manager.

6.3 The employee will be given advance notice of the time, date and place of the meeting. If the initial date is problematic, then one further date will be proposed. If a face-to-face meeting is difficult to arrange then, if agreed by the employee and Headteacher/Executive Headteacher/Line Manager, the meeting may be held over the telephone.

6.4 At the meeting the employee may, if they wish, be accompanied by a workplace colleague or a Trade Union representative.

6.5 If the employee fails to attend a meeting and then fails to attend a rearranged meeting without good reason, their application will be deemed to have been withdrawn.

6.6 Where a request can, without further discussion, be approved as stated in the employee's written application a meeting to discuss the request may not be necessary. The employee will be informed of the organisation's agreement to the request by a confirmation letter as outlined in the section 'Responding to a flexible working request' within 28 working days of the Academy/Trust receiving the request. This time limit may be extended with the agreement of both the employee and Headteacher/Executive Headteacher/Line Manager.

7. Responding to a Flexible Working Request

7.1 The Headteacher/Executive Headteacher/Line Manager will consider the proposed flexible working arrangements, looking at the potential benefits, and adverse effects, to the employee and to the Academy/Trust in implementing the proposed changes.

7.2 Each request will be considered on a case-by-case basis. Agreeing to one request will not set a precedent or create the right for another employee to be granted a similar change to their working pattern.

7.3 The employee will be informed in writing of the organisation's decision as soon as is reasonably practicable, but no later than 14 working days after the meeting.

7.4 The request may be granted in full, in part or refused. The Academy/Trust may propose a modified version of the request, the request may be granted on a temporary basis, or the employee may be asked to try the flexible working arrangement for a trial period. If the request is agreed, then the employee will be sent a confirmation letter which will include details of the new arrangements. The employee should contact their Headteacher/Executive Headteacher/Line Manager within fourteen days if they wish to discuss the new arrangements further or have any concerns.

8. Right to Appeal Decision

8.1 The employee has the right to appeal the decision if their request is refused or is only agreed in part.

8.2 The employee may lodge an appeal within 14 working days of being notified of a decision on their application. This should be done in writing to the Clerk to the Local Governing Body/Trust Secretary and clearly state the grounds on which they are appealing. The appeal will be heard within 14 working days. The employee will then be informed of the outcome to their appeal within 14 working days of the appeal meeting. These time limits may be extended with the agreement of both the employee and the Clerk to the Local Governing Body/Trust Secretary.

9. Trialling New Working Arrangements

9.1 Where there is some uncertainty about whether the flexible working arrangement is practicable for an employee and/or the organisation a trial period may be agreed. If a trial period is arranged the organisation will allow sufficient time for an employee and their Headteacher/Executive Headteacher/Line Manager to implement and become used to the new working practices before taking any decisions on the viability of a new arrangement.

10. Varying an Employee's Contract

10.1 Where flexible working practices are agreed as a permanent change, a variation will need to be made to the employee's contract of employment. A new contract of employment will be sent to the employee within 28 working days of the change to the employee's working pattern being agreed.

10.2 If the employee has any questions or concerns about the new contract of employment, they should contact their Headteacher/Executive Headteacher/Line Manager to discuss the matter further.

10.3 Where a trial period has been arranged the Academy/Trust will provide the employee with a document that details their new working pattern and makes clear that it is only a temporary variation to the terms of the employee's contract. The employee will be informed in writing of the start and end dates of the trial period. The organisation will reserve the right, at the end of the agreed trial period, to require the employee to revert to their previous working arrangement.

11. Review

11.1 This policy will be reviewed by the Wessex Learning Trust Board every three years or earlier if there are any changes to legislation.
